<b><u>"Please Note: Candidates must submit separate applications for each post they wish to apply for. Only then the score obtained in the single Tier-I test be considered for all the relevant applied posts."</u></b>	<b>"Please Note:</b> Subject to fulfilment of the prescribed eligibility criteria, candidates may apply for more than one post through a <b>Single Online Application Form</b> by selecting/ticking the relevant post(s) under the 'Apply For' in <b>Section 3 – 'Apply For &amp; Exam Centre Details'</b> . The application fee shall be payable for each post and shall be calculated accordingly. Only then the score obtained in the single Tier-I test shall be considered for all the relevant posts applied for, post-wise/bunch-wise, wherever applicable.

#### IMPORTANT:

- Candidates who intended to apply for multiple posts but were unable to do so due to the earlier provision shall be **enabled to apply for multiple posts during the correction window**. The schedule for the correction window shall be intimated in due course.
- The last date of submission of online application is **extended from 22<sup>nd</sup> December (Monday) to 27<sup>th</sup> December (Saturday) 2025** and the last date of submission of fee is **27 December 2025 (on or before 11.59 pm)**.
